Conditions of empanelment:

1. Empanelled firm will arrange supply of material as per qualifying minimum standards, specification mentioned in terms & conditions of EESL tender document and notified by MNRE for which models of SPWPS they empanelled to implement the programme.
2. Firm is allowed to use MMS design as per EESL tender & MNRE specifications.
3. Pre-Dispatch Inspection (PDI) will be mandatory before material supply.
4. Empanelled firms will get the list from RHDS/DHDS offices and ensure site survey, geo-tagging and get consents with tri-party agreement (as per prescribed format of RHDS guidelines) from beneficiaries in their favour and submit it to DHDS.

5. Empanelled firm should submit monthly/quarterly progress reports online to RHDS.
6. Remote Monitoring System (RMS) & Geo-tagging will be compulsory for each SPWPS as per terms & conditions of EESL tender and its amendments.
7. The Toll free number will be communicated to the RHDS and concerned district units.
8. The list of service center / call center as submitted to Commissionerate is supposed to be made available to the concerned offices and any change may be intimated.
9. The bill of quantities (BOQ) and the prescribed quotation of the firm will be communicated to the district units and RHDS.



Installation of 10 HP SPWPS subsidy will be calculated on the L-1 rate (GST inclusive) of 7.5 HP.

Final empanelment of SPWPS with normal controller for three categories (Surface: 10 HP DC/AC, Submersible: 10 HP DC) of M/s CRI Pumps Pvt. Ltd., Coimbatore will be issued after submitting pending test reports. In failure of submission of pending reports and original reports, empanelment will be cancelled and other legal action will be taken as per agreement, LoA & empanelment.

All terms & conditions of PM-KUSUM, EESL tender, LoA & empanelment, undertaking given by firm, programme guidelines, other time to time issued directions of MNRE-GoI & RHDS/Commissionerate of Horticulture should be strictly followed by empanelled firm.

The RHDS/Commissionerate of Horticulture will decide any matter, either on reference or suo moto, in the interest of State & beneficiary. Subject to the PM-KUSUM guidelines.
